

Terms and Conditions of Use

Welcome to Trad3s.com (hereinafter also “Trad3s” or “we/our”). We offer a software as a service solution “SaaS”, hereinafter referred to as “the Software” through our website [Trad3s.com](#) (the “Website”). The Software enables you (the “User”) to create trading rules and automate their operation on third-party cryptocurrency exchanges.

These Terms and Conditions (the “Terms”) apply to the relationship between Trad3s and its Users for any use of the Website and the Software that Trad3s offers. You are not permitted to use the Website and the Software without accepting these Terms.

By accessing the Website, you are agreeing to be bound by these Terms of Service, all applicable laws and regulations, and you agree that you are responsible for compliance with any applicable local laws. 1.1 Trad3s: Trad3s is a trademark used by Ontwikk3ltuin B.V. to refer to its automated trading software that creates trading rules to operate on third-party exchanges. Trad3s trademark is registered under number: 1436788 at [www.boip.int](#)

1.2 User(s): individual consumers or legal entities making use of the Website or Software. Also referred to as “you”.

1.3 Software: developed and fully owned by Trad3s, the Software enables users to create various trading rules on a user-friendly digital interface.

1.4 Rules: trading strategies, built with indicators such as but not limited to price, volume, and market capitalization. The range of rules is subject to change in accordance with Trad3s’s future amendments to the interface.

1.5 Free Simulator: the simulator trial of the Software available to users for free for a 3 month period of time. The availability of rules and functionalities of the Software is limited in the Simulator Trial.

2. Registration and personal account

2.2 To have initial access to the Software, you will need to register and create a personal account. You can register using your personal email or opt to log in through your Google profile in order to use the Website and the Software.

2.3 You must protect the login details of your account and keep your password secret. We will assume that all activity from your account is carried out by you or under your supervision.

3. Offers and prices

4. Free Demo Trial

4.1 Upon registration, you may use the Free Demo Trial whereby you would be entitled to use the Software Simulator for a period of 3 months from the time it is initiated. After this period the Simulator will be automatically disabled.

4.2 Some software functionalities are subject to limitations during the Demo Trial. Trad3s reserves the right to amend the structure, length, and availability of Demo Trial and trading rule options.

4.3 Trad3s reserves the right to introduce or withdraw the option for users to use the Software or Demo at any time.

5. Credits and payments

5.1 You need Credits to use our live trading Software and its range of functionalities.

5.2 Credits are offered on the basis of 1-to-1 with 1 Credit is equal to the value of 1 Euro.

5.3 Costs of Credits will be debited from the payment method you choose in the Payment Gateway. You will be required to pay a transaction fee(s) or it will be debited from the original value. You will receive the Credits you pay for, minus the transaction fee if it is not included. Credit transactions are non-refundable.

5.3.1. Whenever we face a chargeback on your credit card, we face costs. According to general chargeback rules, there is a fee attached to each transaction dispute. This fee is to be paid by you, the client, to cover chargeback administration costs. The acquiring bank has a lot of influence in determining the fee amount, as does your processor. Our type of service also affects the price tag, along with several other factors. Therefore the minimum chargeback fee, payable to us at any time we face a chargeback from your credit card is 250 Euros.

5.4 Trad3s will deduct 20% of the profit you make in credits. You must have credits to cover the profit of your liquidated position(s) or Trad3s will not close the trade(s). For example, if you have €100 in profit Trad3s will take €20 in credits or 20 credits.

5.5 By choosing our payment options, you grant your permission for us to initiate a payment or a series of payments on your behalf via a payment provider. All your payment details will be confidentially secured.

5.6 A Trad3s account can be deactivated if your account remains in a negative credit balance for 30 days or longer.

5.7 All Credits will expire and be lost if an account remains inactive with no trading activity for over 1 year since the last transaction.

5.8 A user can freeze an account and access on their exchange at any time by disconnecting their Trad3s account from the Exchange by removing the exchange connection in both Trad3s and at their exchange. Email support if you would like the account to be completely closed.

5.9 Data on a User's account may be subject to deletion at any time without notice. All user funds will not be affected since they are in the exchange

6.1 Users have the right to cancel their Demo Trial and Account at any time.

7.2 At all times, Trad3s reserves the right to retain the Credits that Users have paid for after 1 year of account inactivity.

8. Account Deletion

8.1 If you would like to terminate your activity on Trad3s and permanently delete your account and User details, you have a right to request the Trad3s Support Team to delete your account. Please contact us by message via our website.
